

1. PURPOSE

- 1.1 The Parties have agreed on General Conditions for the Supply of Certification Services (the "General Conditions") as well as the Specific conditions (the "Specific Conditions") of the Subscription Contract specifying the methods for issuing and using the Certificates provided by SG Trust Services. The purpose of this sales contract is to specify the sales terms for the Connection Kit to the Client for the use of the Physical Medium defined in article 2 of the General Conditions.
- 1.2 The provisions of the General Conditions and the Specific Conditions are fully applicable to the Connection Kit Sales Contract. In case of a contradiction between the articles of the General Conditions or the Specific Conditions and the provisions of the Connection Kit Sales Contract, the latter provisions shall prevail.

2. DEFINITIONS

- 2.1 Unless there is a contrary definition in the body of this Connection Kit Sales Contract, the terms in uppercase letters shall have the definitions set forth in article 2 of the General Conditions.
- 2.2 Furthermore, in the Connection Kit Sales Contract the following definition is applied:
Price: sale price of the Connection Kit as described in the contract above.

3. INTENDED USE OF THE CONNECTION KIT

SG Trust Services shall not be held responsible for use of the Connection Kit other than for reading a Physical Medium provided by SG Trust Services.

4. DELIVERY

The Connection Kit is sent by SG Trust Services to the address specified above by the Client.

5. INSTALLATION

Creation of the Private Key. Under the Client's responsibility, each Subscriber creates on the Physical Medium the Private Key associated with a Certificate.

6. USE OF THE CARD READER

- 6.1 **Installation prerequisites for the use of Certificates** The Client recognizes that the Physical Medium must be installed and used on a computer workstation that meets the minimum specifications defined by SG Trust Services in the document entitled "Installation prerequisites for the use of Certificates" appended to the Subscription Contract. The Client recognizes that these minimum specifications may be modified. In that case, SG Trust Services shall inform the Client beforehand by any means.

- 6.2 The Client agrees to use the Physical Medium in compliance with the instructions provided by SG Trust Services.

7. CLIENT COMMITMENTS

- 7.1 **Mandatory information.** The Client guarantees that the Certificate Manager and the Subscriber have been informed of the provisions of the Connection Kit Sales Contract, and in particular of the associated rights and obligations. The Client agrees to have the Certificate Manager and the Subscribers respect the provisions of the Connection Kit Sales Contract.
- 7.2 The Client recognizes that the provisions of article 7 are vital for SG Trust Services.

8. FINANCIAL TERMS

- 8.1 The transfer of ownership of the Connection Kit occurs on the day the Price is paid in full.
- 8.2 The Price must be paid by the Client 30 calendar days following the date of the invoice. Any invoice not paid by that date shall generate interest charges equal to one and one-half times the legal interest rate. Interest charges begin to accrue on the day following the payment due date and shall continue until the invoice is paid in full.

9. SUBCONTRACTING

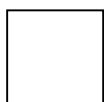
The Client expressly authorizes SG Trust Services to subcontract all or part of its obligations defined in the Connection Kit Sales Contract.

10. LIABILITY

In case of a decision incurring any liability of SG Trust Services to the Client, the damages and interest and indemnities for which it is liable for any cause whatsoever shall not exceed an amount equal to the Price.

11. APPLICABLE LAW - SETTLEMENT OF DISPUTES

- 11.1 The Sales Contract of Connection Kit is subject to French law.
- 11.2 In case of dispute concerning the interpretation, formation, or execution of the Sales Contract or its amendments, and if an amicable settlement cannot be reached within one month of the start of the dispute, the Parties expressly recognize the exclusive jurisdiction of the Paris Tribunal, notwithstanding a plurality of defendants, provisory settlements, third-party complaints, or conservatory measures.
